# About NCCCC 2026

The Centre for Training & Research in Commercial Regulations is thrilled to announce the return of our National Corporate Client Counselling Competition for its second edition. This competition was envisioned to allow students to engage with challenging, real-world corporate law issues. This unique platform will test participants' skills in handling a complex corporate dispute scenario, requiring adept client management, legal interpretation, and strategic counselling.



The resounding success of our 1<sup>st</sup> edition reflected the impact and credibility this platform has built. 32 teams participated in the inaugural edition and they were judged by professionals from leading law firms like SAM, CAM, Khaitan & Co., JSA, Trilegal and more.

Additionally there was also a workshop for the participants. The event offered participants not just recognition but exciting cash prizes and valuable rewards like internships at leading law firms. Participants walked away with practical skills, confidence, and constructive feedback that extended far beyond the event itself.

# Areas of Law

The areas of law covered during the competition are broad and varied, reflecting the complexities of modern corporate practice.

The list of laws and subjects is indicative and non-exhaustive, including but not limited to:

- Company Law
  - Contract Law
  - Insolvency Law
  - Banking & Finance Law
  - Securities Law
  - Capital Markets

## Eligibility

This competition is open to all law students enrolled in either

- a 5-year integrated law program or
  - a 3-year LLB program.

# Registration

- Participants can register through two modes: **University-Nominated Teams** or **Individual Open (Non-university) Teams**.
- Universities may send official teams through their respective ADR or Moot Court societies.
- Additionally, **Open Teams** will be selected based on an evaluation of their CVs. These slots are intended to allow individual students to form teams with others.  
(Note : This is subject to availability of slots)
- The registration fee for the preliminary rounds is **INR 4500**, and an additional fee of **INR 5500** will apply for those advancing to the final rounds.

# Competition Structure

## Preliminary Rounds

- **Dates:** February 27<sup>th</sup>-28<sup>th</sup>, 2026 (Online)
- **Teams Participating:** A total of **40 teams**, including both mixed and institutional teams.
- **Rounds:** Each team will participate in two rounds, each based on a different proposition involving distinct areas of law. One round will be conducted per day.
- **Scoring:** Teams will be evaluated on cumulative scores across both rounds. The **top 4** teams will qualify for the advanced rounds based on their cumulative scores from both preliminaries.
- **Clients:** Selected students from MNLU Mumbai will role-play as clients in all rounds.
- **Format:** *20 minutes of client counselling*, during which counsels will engage with the clients to understand their legal position and available options, followed by a *10-minute post-consultation discussion*. This will be followed by feedback and scoring.

## Advanced Rounds

- **Dates:** April 11<sup>th</sup>, 2026 (On-Campus at MNLU Mumbai)
- **Semi-Finals:** The top 4 teams from the preliminary rounds will compete in the semi-finals, judged by a 3-judge panel.
- **Finals:** The 2 teams with the highest scores in the semi-finals will advance to the final round, judged by a 5-judge panel. The highest-scoring team will be declared the competition winner.
