# VISION AND MISSION



The vision of the 5th NALSAR-CCI Antitrust Moot Court Competition this year is to set the benchmark for antitrust law moots by making NALSAR-CCI the Premier Antitrust Competition in India. We aim to organize the biggest and grandest moot which will promise an enriching experience for all the stakeholders without sacrificing on quality and fairness. We are bringing in top law firms and research databases to provide the best mooting experience for our participants.

Individuals with distinguished knowledge and prestige in the area of competition law are being invited as judges. Furthermore, in addition to monetary prizes, the winners of various awards will receive internships, subscriptions to online study materials, and multiple goodies.

# COMPETITION STRUCTURE

The Competition shall comprise two stages:

- Memorandum Elimination Round: The results of this round shall be based on the evaluation of Memorandums and shall determine the 24 teams that will proceed to the Oral Rounds.
- Oral Rounds: The teams that qualify the Memorandum Elimination Round shall be eligible to participate in the Oral Rounds, which shall comprise Preliminary Rounds and Advanced Rounds.

# ELIGIBILITY & REGISTRATION

The Competition is open to students enrolled bona-fide on a regular basis in an Undergraduate/Postgraduate law course (including LL.M. programs) or its equivalent conducted by any institution recognized by the Bar Council of India.

There is no limit on the number of teams applying from one institution. Interested teams are required to register for the Competition by filling out the Registration Form which can be accessed on our website:

Teams of 2 (speakers) or 3 (2 speakers and 1 researcher) are welcome to register. Once registration has been verified teams will be assigned a Team Code (" TC- XX") for identification for the duration of the Moot. Registrations close on 31st January, 2026.

Winning Team Award: The winning team will receive a Trophy, a cash prize of INR 1,00,000/-, three one-year complimentary subscriptions to SCC Online Web Edition worth INR 32,000 each, and a chance at an Internship at Trilegal.

Runners-Up Team Award: The runners-up team will receive a Trophy, a cash prize of INR 50,000/-, and a chance at an Internship at Trilegal.

Best Speaker will receive a Trophy and a cash prize of INR 10,000.

# AWARDS & PRIZES

Best Researcher will receive a Trophy, a cash prize of INR 7,500 and a chance at an Internship at Trilegal.

Best Speaker in the Finals will receive a Trophy and a cash prize of INR 7,500.

The team with the Best Memorandum – Informant will receive a Trophy and a cash prize of INR 12,500.

The team with the Best Memorandum – Opposite Party will receive a Trophy and a cash prize of INR 12,500.

All participating teams will be provided with a certificate of participation or a certificate of merit in accordance with the performance of the team.

The dates for the activation of subscription will be notified by the Organizing Committee to the participants in due course. A training session for the participants will also be held, the dates of which will be notified by e-mail post registration.
