THEMES

The manuscripts must pertain to the field of intellectual property law or related fields such as media and technology law.

TYPES OF SUBMISSIONS

Journal of Intellectual Property and Legal Studies invites original, unpublished manuscripts from all academicians, authors, legal professionals and law students in the following categories:

I. Research Articles (3000-6000 words, excluding footnotes)

Submissions in this category should deeply engage with the theme and literature of a specific topic. The article must review current practices in the field, identify any gaps, and provide innovative reassessments along with constructive recommendations. Theoretical pieces are also encouraged.

II. Brief Research Articles (1500-3000 words, excluding footnotes)

Brief research articles should be concise, focusing on a specific issue while offering new perspectives and critical insights. They should present clear arguments and propose alternative ways of understanding the selected topic.

I. Case Notes / Book Review (1200-2500 words)

This category analyses contemporary judicial decisions, legislative actions, or policy proposals. Notes and comments should trace the development of relevant case law and discuss their implications. Similarly, legislative comments or policy proposals should identify the objectives and anticipated impact of the legislative action or policy being analyzed.

Please note that word limits are exclusive of footnotes. In compelling circumstances, the Editorial Board may be flexible with respect to the word count depending on the quality of the submission.

DEADLINE

The deadline for submissions is 28th February 2026. Please note that we will be unable to accept submissions for this volume after this date.

GENERAL INSTRUCTIONS

- All manuscripts must include an abstract of 150 words, with 05 Keywords.
- Up to two authors are permitted for all submission categories.
- Submissions must be original, unpublished, and not under review elsewhere. Plagiarism will result in immediate disqualification from publication in JIPLS.
- Authors bear full responsibility for any disputes arising from their manuscript, including issues related to copyright, defamation, objectionable content, or contempt, and agree to accept any losses incurred from violating copyright or other rights.
- While adhering to word limits is recommended, the journal may allow flexibility based on the quality of the article.
- The similarity percentage of the manuscript should be within 10% as per The UGC Academic Integrity Regulations 2018 (https://www.ugc.ac.in/pdfnews/7771545_academic-integrity-Regulation2018.pdf)
- AI generative content must be avoided.
- Co-authorship of maximum 3 authors is allowed.

FORMAT

- The first page of the manuscript should include the title, authors' names, their institutional affiliations, and an abstract with keywords.
- The second page should begin with the main body of the manuscript.
- The manuscript must be anonymised and must not contain any personal identifiers (e.g., author name, institutional affiliation, personal acknowledgements, etc.).
- Submissions are to be made in English language only.
- Text of the manuscript should be typed in Times New Roman, 12-point Font size, with 1.5 line spacing.

- Headings should be in Capital letters; sub headings in Title-case, underlined, and bold; and sub-sub headings in Title-case, underlined.
- Please ensure that your submission is made as a Microsoft Word document (.docx).
- The footnotes should be in Times New Roman, 10-point Font size, with 1.0 line spacing.
- Authors must use the OSCOLA (4th edition) citation style.

- All submissions must be accompanied with a covering letter indicating the name of the author, title of the submission and the email address of the author. The submissions will be reviewed and edited by the Editorial Board under the supervision of the Editor in Chief.
