

# **RULES AND REGULATION**

## **TEAM COMPOSITION & ELIGIBILITY**

- Each team must consist of exactly 2 members
- All participants must be law students enrolled in either a 5 year integrated law course or a 3 year law course at a recognized institution.

## **REGISTRATION**

- Registration is open for all law students (no fee)
- Registration is mandatory for participation
- Once a team registers by completing formalities given, a Team Code shall be assigned to the team on spot.
- All participants must complete their registration on or before 15th March 2026.

# RULES & REGULATIONS

## PROCESS OF THE COMPETITION

- In each round, participating teams will be provided with a case scenario along with a dummy client, who will simulate a real-life client seeking legal advice.
- Each round will involve a client counselling session where participants are required to:
  - (a) Understand the clients problem
  - (b) Identify relevant legal issues
  - (c) Explain applicable laws clearly
  - (d) Suggest appropriate legal remedies in professional manner
- Participants must adhere strictly to the time limits prescribed for each round.
- The final 5–10 minutes of each round shall be reserved for interaction with the judges, during which the judges may pose questions and seek clarifications to evaluate the participants legal knowledge, reasoning, and counseling skills.
