MODE AND FORMAT

- Panel Discussions: Focusing on specific themes allows for exchanging ideas and diverse perspectives.
- Research Paper Presentations: Research scholars will present their work, followed by Q&A sessions for constructive feedback.

Outcomes

- Publication: Selected papers will be published in CHRIST University Law Journal (CULJ) or as a conference proceedings volume, or in the form of an Edited Book with an ISBN, providing a lasting resource for legal scholars and practitioners.
- Networking: Facilitate connections between scholars, leading to potential collaborations on future research projects.
- Mentorship: Senior scholars will offer guidance to early-career researchers, helping them enhance their research skills and methodologies.

SUBMISSION GUIDELINES

- All submissions shall be made in electronic form (.doc format only) through the Google Form available at - <https://forms.gle/6bPgfwI4inuBfMHk9>
- Submissions sent to any email address or through any mode other than the prescribed Google Form will not be considered for the conference.
- The paper should be submitted in English language.
- Submissions should be up to **between 3,000 and 6,000 words**, inclusive of references and footnotes.
- The manuscript should be formatted in Times New Roman with a font size of 12 for the main text and 14 for headings, with single line spacing and bold headings.
- All submissions shall conform to the APA 7th Edition citation style.
- The paper shall be accompanied by an **abstract not exceeding 300 words**.
- Authors shall provide a maximum of five keywords, which shall not be included in the prescribed word limit.
- Co-authorship is permitted for up to two authors.
- The cover page shall contain the title of the paper, name of the author(s), designation, postal address, e-mail address, contact number, and the name and address of the affiliated college, university, institution, or firm.
- A brief profile of the author(s), not exceeding 250 words, should be submitted along with the Paper.
- The submissions should not have been previously published or under consideration for publication, presentation or any other competition elsewhere.
- All contributions shall represent original ideas and interpretations supported by critical evaluation and analysis.
- The overall similarity index, including AI-generated similarity, shall be below 10%.
- The submission should be free from unacknowledged AI-generated content.
- Any form of plagiarism shall result in immediate disqualification.
- Authors of selected papers shall be notified separately, and only such authors shall be eligible to present their papers upon payment of the prescribed registration fee.
- Selected papers may be considered for publication in the CHRIST University Law Journal (CULJ), or a conference proceedings volume, or an edited book carrying an ISBN.
- The registration fee (non-refundable) shall be payable only after the acceptance of the Full Paper.
- Participants opting for offline participation shall be responsible for arranging and bearing their own travel and accommodation expenses.
- The University may provide assistance in arranging accommodation for participants attending in offline mode, upon request.

SUBMISSION & SELECTION PROCEDURE

- All submissions shall be made in electronic form (.doc format only) through the Google Form available at: <https://forms.gle/6bPgfwizinuBfM7Hk9>.
- All submitted papers shall undergo an initial screening by the Organising Committee to assess their relevance to the conference theme and compliance with basic academic standards.
- Full papers shall undergo a peer-review process in accordance with the applicable academic standards and publication requirements.
- Submissions shall be evaluated on the basis of originality, thematic relevance, conceptual clarity, methodological rigour, and contribution to existing scholarship.
- Authors of selected submissions shall be informed through the official e-mail address provided in the Google Form.
- Upon selection of the papers, authors shall be invited to present their papers at the Conference.
- A common WhatsApp group may be created for all selected participants to facilitate effective communication and coordination regarding the conference.
- Certificates will be awarded to all the Paper Presenters. In case of Co-Authorship, certificates will be given to both authors, but only one can present.
- Selected submissions shall be considered for publication only upon obtaining the consent of the author(s) and co-author(s), wherever applicable.
- All selected manuscripts shall undergo an editorial review and editing process prior to publication.
- Publication shall be undertaken only after the completion of the editorial process and necessary author approvals.
- The final publication is expected to be completed within approximately three to four months from the date of the conference.
- No separate publication fee or additional charges shall be levied for publication.

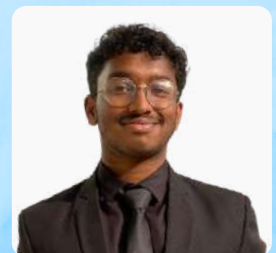
