ABOUT 2025 EDITION OF ABHILEKH

The 2025 edition of Abhilekh, themed “**Building Inclusive Societies: Quest for Quality Legal Aid,**” shifted the focus more directly towards legal aid, social protection and the lived realities of vulnerable and informal workers.

A significant focus of the edition was the position of women in domestic work, examining the lack of comprehensive social security available to domestic workers and the vulnerabilities created by informal employment arrangements. The edition highlighted issues of income security, healthcare, employment benefits, job security and the absence of adequate legislative protection.

It further examined the challenges faced by gig and platform workers, particularly the limitations of existing social-security frameworks. The discussion addressed issues such as worker classification, access to benefits, workplace injuries, economic insecurity and the difficulties created by the distinction between employees, unorganised workers and gig workers.

ABOUT 2026 EDITION OF ABHILEKH

The 2026 edition of Abhilekh turns its focus towards the foundational ideals of Legal Aid and Access to Justice, examining the extent to which the legal system can ensure meaningful and equitable access to justice for all. Building upon the publication’s earlier engagement with labour rights, inclusion and social protection, this edition seeks to explore the legal, institutional and socio-economic dimensions that shape an individual’s ability to understand, claim and enforce their rights.

The edition will engage with the constitutional vision of equal access to justice, the role of legal aid institutions, legal services authorities, legal aid clinics and alternative mechanisms of dispute resolution. It will also foreground the experiences of communities and individuals who continue to encounter barriers arising from poverty, social marginalisation, lack of legal awareness, geographical limitations and institutional constraints.

Through diverse perspectives and critical legal discourse, Abhilekh 2026 seeks to examine both the existing framework of legal aid and its effectiveness in practice, while encouraging reflection on how legal institutions can become more accessible, inclusive and responsive. The edition ultimately seeks to reaffirm that justice is meaningful only when it is accessible to those who need it most.

THEME

Access to justice extends beyond the formal availability of courts and legal remedies. For many, economic hardship, social exclusion, lack of legal awareness, institutional barriers and unequal access to legal assistance continue to impede the effective exercise of rights.

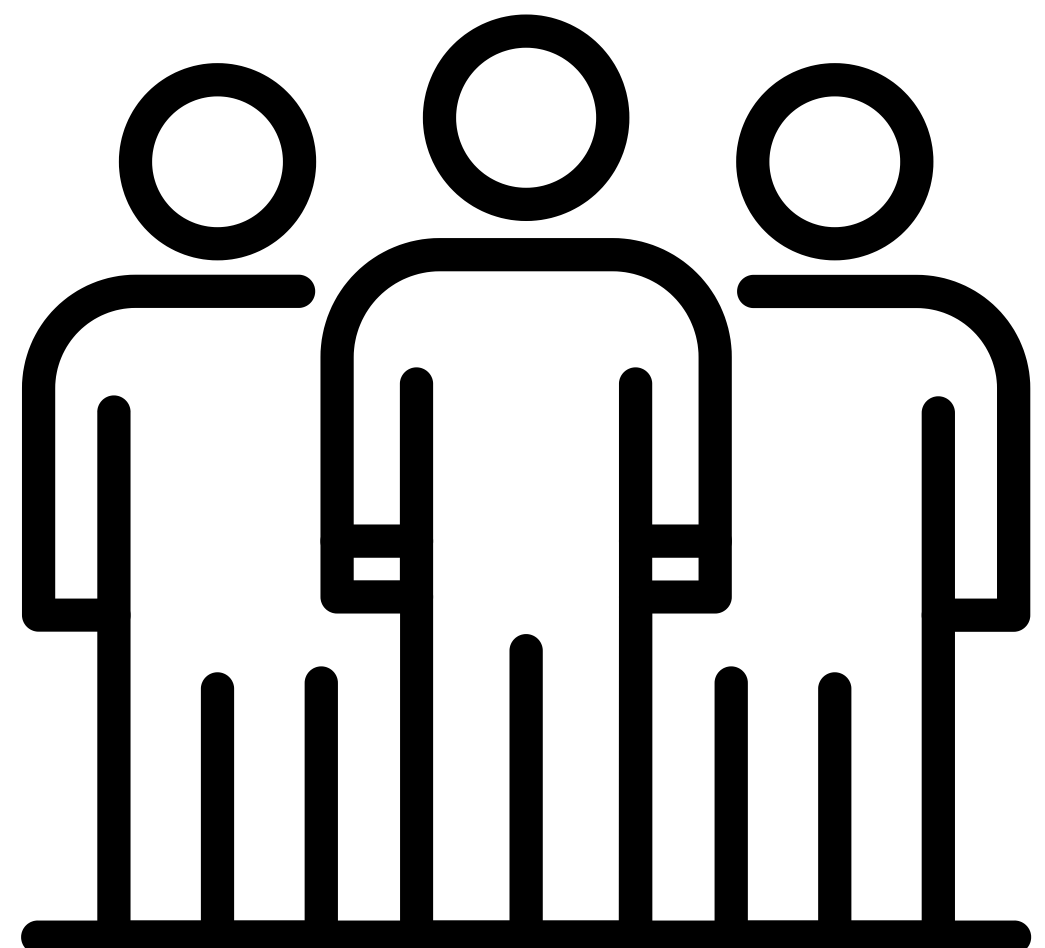

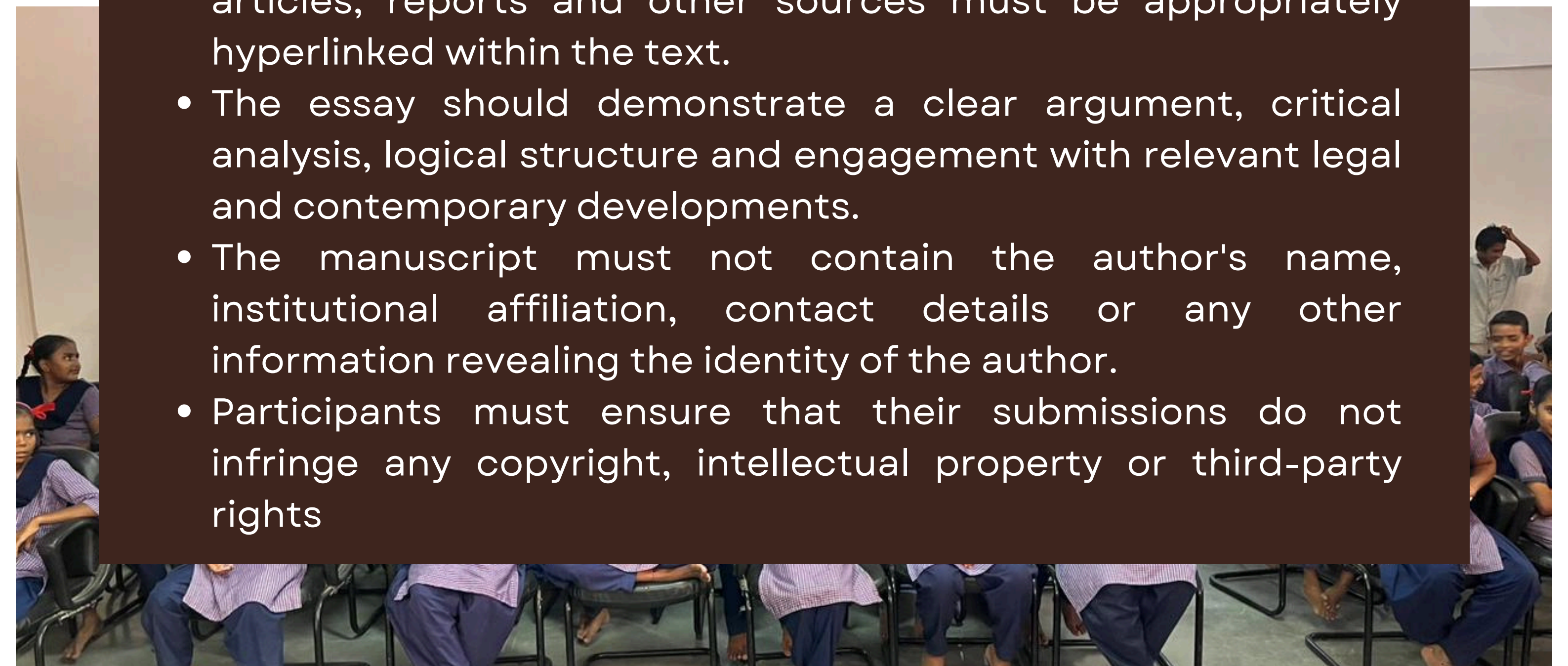

SUBMISSION GUIDELINES

- The submission must be original and unpublished and must not have been submitted elsewhere for publication or consideration.
 - Co-authorship is permitted for a maximum of two authors.
 - The manuscript must maintain a plagiarism similarity of not more than 10%. Submissions exceeding the prescribed limit may be rejected.
 - The essay must be submitted in Microsoft Word (.doc/.docx) format.
 - The essay must be formatted in Times New Roman, 12-point font, with 1.5 line spacing and justified alignment.
 - 1-inch margins must be maintained on all sides.
 - Hyperlinks are mandatory for all citations and sources relied upon in the essay. Relevant authorities, cases, statutes, articles, reports and other sources must be appropriately hyperlinked within the text.
 - The essay should demonstrate a clear argument, critical analysis, logical structure and engagement with relevant legal and contemporary developments.
 - The manuscript must not contain the author's name, institutional affiliation, contact details or any other information revealing the identity of the author.
 - Participants must ensure that their submissions do not infringe any copyright, intellectual property or third-party rights
