COMPETITION RULES

ELIGIBILITY CRITERIA

All students enrolled in a three (3) year LL.B. programme or a five (5) year integrated law programme shall be eligible to participate in the Competition. Multiple teams from the same institution are permitted, provided that each team submits a duly filled and signed No Objection Certificate (NOC) in the prescribed format provided by the Organising Committee, printed on the official letterhead of the participating institution and duly issued by the competent authority of the institution. Students enrolled exclusively in postgraduate or diploma programmes are not eligible to participate.

TEAM COMPOSITION

- Each team shall consist of a minimum of two (2) and a maximum of three (3) members. A three-member team shall comprise two (2) Speakers and one (1) Researcher, whereas a two-member team shall comprise two (2) Speakers, one of whom shall also be the Researcher.
- The names and designation of the team members (Speakers and Researcher) shall be specified at the time of registration. The order and designation of the team members shall ordinarily remain unchanged throughout the Competition.

- No substitution of a team member or alteration in the team composition shall be permitted after the closure of registration, except under exceptional circumstances and only with the prior written approval of the Organising Committee.

LANGUAGE

The official language of the Competition shall be English. All memorials, oral pleadings, written submissions, and official communications shall be communicated exclusively in English.

DRESS CODE

Participants are required to appear in formal court attire throughout the Competition:

- **Male Participants:** White shirt, black trousers, black tie, black blazer, and black formal shoes.
- **Female Participants:** White shirt with black trousers/skirt or white salwar suit, black blazer, and black formal footwear.

FORMAT OF THE COMPETITION

The 1st UPSIFS National Moot Court Competition, 2026 shall be conducted in two phases. The Preliminary Rounds shall be held in online mode on 15th-16th October 2026 via Microsoft Teams, while the Researcher's test, Quarter-Final, Semi-Final, and Final Rounds shall be conducted offline on 30th- 31st October 2026 at Uttar Pradesh State Institute of Forensic Science (UPSIFS), Lucknow.

Draw of lots: The side to be represented (Petitioner/Respondent) shall be decided by draw of lots at different stages during the competition.

PRELIMINARY ROUNDS:

- The Preliminary Rounds shall be conducted online via Microsoft Teams on 15th-16th October 2026.
- Each team shall argue twice, once as the Petitioner and once as the Respondent. Each round shall have a total duration of 30 minutes.
- The qualification of teams for the Quarter-Final Rounds shall be determined based on their overall performance. The aggregate score of the Speakers and the Memorial Score shall be considered for determining the outcome and ranking of teams.
- The Top Eight (8) Teams shall qualify for the Quarter-Final Rounds.

RESEARCHER'S TEST:

- The Researcher's Test shall be conducted offline at the Competition venue on 30th October 2026, for the Researcher of each team qualifying for the Quarter-Final Rounds.
- The Test shall consist of 50 Multiple Choice Questions (MCQs), to be completed within thirty (30) minutes.
- The Researcher securing the highest marks shall be awarded the Best Researcher Award.

QUARTER-FINAL ROUND:

- The Top Eight (8) Teams shall compete in the Quarter-Final Rounds, to be conducted offline at UPSIFS, Lucknow on 30th October 2026.
- The Quarter-Finals shall be conducted on a Knockout Basis. Each team shall argue from one side only, as determined through the Draw of Lots. Each round shall have a total duration of 60 minutes.
- The win-loss shall be decided on the basis of the aggregate Speaker Score. No Memorial Score shall be added in the Quarter-Final Round. The team securing the higher aggregate Speaker Score shall win the round and qualify for the Semi-Final Round.

SEMI-FINALS:

- The Top Four (4) Teams shall compete in the Semi-Final Rounds on 30th October 2026.
- The Semi-Finals shall be conducted on a Knockout Basis, with each team arguing from one side only, as determined through the Draw of Lots. Each round shall have a total duration of 90 minutes.
- The win-loss shall be decided on the basis of the aggregate Speaker Score. No Memorial Score shall be added in the Semi-Final Round. The team securing the higher aggregate Speaker Score shall win the round and qualify for the Final Round.

FINAL ROUND:

- The Top Two (2) Teams shall compete in the Final Round on 31st October 2026.
- The Final Round shall be conducted on a Knockout Basis, with the side to be represented determined through the Draw of Lots. The round shall have a total duration of 120 minutes.
- The winner shall be determined solely on the basis of the aggregate Speaker Score. No Memorial Score shall be added in the Final Round. The team securing the higher aggregate Speaker Score shall be declared the Winner, while the other team shall be declared the Runner-Up.

REGISTRATION

The Competition shall be conducted in two phases:

Phase I: Online Preliminary Rounds

Phase II: Offline Researcher's Test, Quarter-Final, Semi-Final and Final Rounds at UPSIFS, Lucknow

REGISTRATION FEE:

₹3,000/- per Team, the Registration Fee shall cover participation in the Online Preliminary Rounds.

The Top Eight (8) Teams qualifying for the Quarter-Final Rounds shall advance to the Offline Phase of the Competition. Each qualifying participant **shall pay an Accommodation & Hospitality Fee of ₹1,000/- per person**, inclusive of accommodation and meals during the Offline Phase.
