The objective is to provide a platform for aspiring scholars of International Law to think prospectively, analyse complex legal questions, and apply established legal principles to evolving factual scenarios. It seeks to prepare young minds to address legal challenges that may emerge in the real world.

This requires a strong foundation in the traditional principles of International Law, an understanding of International Relations, adherence to the principles and values enshrined in the United Nations Charter, respect for the peaceful settlement of disputes, and a commitment to advancing the interests of humanity. The forum also serves as a platform to identify future advocates who may represent States, legal advisers who may guide governments, and judges who may one day adjudicate such matters. The competition encourages participants to engage with recognized sources of International Law and develop practical, principled, and sustainable solutions.

Today's Moot Court Proposition may become tomorrow's reality, and today's students are tomorrow's public international lawyers. We are a forum that seeks to connect the two by nurturing analytical excellence, and a deeper commitment to the rule of law. Eligibility, Awards and Scholarships

The Competition shall be open to all students who are bona fide and regularly enrolled in an undergraduate law programme (3-year/5-year or its equivalent) offered by any recognised institution in India or abroad, duly accredited by the competent authority. A recognized institution shall be entitled to send **only one team** to the competition.

In a system where a university has constituent colleges, each college can register a team or the university as such can be represented by a team comprising students from different constituent colleges.

Winning Team:

Cash prize of **INR 75,000/ 777 USD** and Internship at RCIL.

Runners-Up Team: Cash prize of **INR 50,000/518 USD** and Internship at RCIL.

Best Speaker and Best Memorial: Cash prize of **INR 30,000/311 USD**.

Top 12 International teams shall be awarded 1000 USD Scholarship as per the RIMC rule book, with a view to promote International Law Studies and research across various regions.

Teams receiving the scholarship shall be **mandatorily required** to remain present “in person” for the entire duration of International Law Week, from 20 November to 5 December 2026. **Scholarship shall be provided in the form of sustenance fund and actual needs.**

Letter of Intent and Letter of Authorization

- The Letter of Authorization (LoA) and Letter of Intent (LoI) to participate is to be done at the earliest. The last date for submission of the Memorials is 15 September 2026.
- The timely submission of the LoA and LoI will enable the RIMC Organising Committee to allocate team codes and make necessary logistical arrangements for the smooth conduct of the competition.

- Participants → LoA & LoI Submission (before last date) → Team Code Allocation → Memorial Submission (before last date) → Memorial Elimination Round → Oral Rounds → Awards & Recognition.
- Given the scholarships provided for International Law Week, every opportunity involves significant financial commitments and resources. Participants are therefore requested to make responsible and informed decisions while accepting the scholarship and participating in the event.

The Competition shall comprise of two stages:

Memorial Elimination Round:

The results of this round shall be based on the evaluation of Memorials and shall determine the 30 teams that will proceed to the Oral Rounds.

In order to promote merit-based participation, there shall be **no registration fee** or accommodation (including food) fee charged to participants who qualify through the Memorial Elimination Round and advance to the Oral Rounds.

Oral Rounds:

The teams that qualify the Memorial Elimination Round shall be eligible to participate in the Oral Rounds, which shall comprise of Preliminary Rounds and Advanced Rounds i.e quarter finals, semi- finals and finals.
