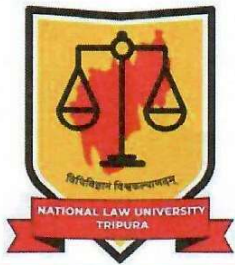

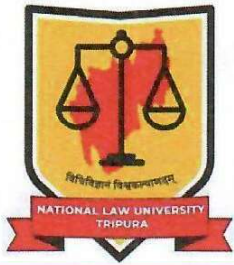

a. The Research score for research papers would be augmented as follows:

Research Papers published in the journals ranked by SC Imago/SCOPUS/Web of Science/Peer-Reviewed Journals listed by the UGC (Impact factor to be determined as per Thomson Reuters/ SJR list):

- Paper in refereed journals without impact factor - 5 Points
- Paper with impact factor less than 1 - 10 Points
- Paper with impact factor between 1 and 2 - 15 Points
- Paper with impact factor between 2 and 5 - 20 Points
- Paper with impact factor between 5 and 10 - 25 Points
- Paper with impact factor >10 - 30 Points

For the research papers cited by Supreme Court/High Court, the research score shall be augmented as follows:

- Cited by Supreme Court – 30 Points
- Cited by High Court – 20 Points

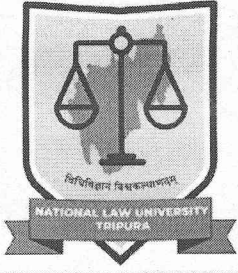
The augmentation of research score for the research papers will either be based on the impact factor as per Thomson Reuters/SJR or on the basis of the citation by the Supreme Court/High Court. If a research paper has impact factor and also cited by the Supreme Court/High Court, then the highest score of anyone should be taken.

- b.** Two authors: 70% of total value of publication for each author.
- c.** More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.

In case of Research Projects:

- Joint Projects: Principal Investigator and Co-Investigator would get 50% each.
- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for supervisor and co-supervisor. Supervisor & co-supervisor, both shall get 7 marks each.
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b)- Policy Document and 6. Invited Lectures/Resource Person/Paper Presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.
