## ❖ About Sri Vishwanath Pasayat

Sri Vishwanath Pasayat occupies a place of enduring distinction in the legal history of Odisha. An illustrious son of the soil, he is remembered as a legendary figure of the freedom movement and an eminent jurist- one who translated the ideals of India's independence struggle into a lifetime of principled legal service.

Sri Pasayat's career was marked, above all, by his singular dedication to the cause of the underprivileged. He devoted his practice to securing justice for the poor and the downtrodden, at a time when access to law remained the preserve of the few.

It was this unwavering commitment that led Hon'ble Justice V.R. Krishna Iyer, one of the most eminent jurists in the history of the Supreme Court of India, to describe him as a "marvel of an Indian" - a tribute reflecting the rare esteem in which he was held within the legal fraternity.

His legacy has been carried forward with distinction by his son, Hon'ble Justice Arijit Pasayat, who served as a Judge of the Supreme Court of India, and earlier as Chief Justice of the Kerala High Court and the Delhi High Court.

In tribute to Sri Vishwanath Pasayat's life and ideals, the Vishwanath Pasayat Memorial Committee, Cuttack, has been instrumental in instituting moot court competitions and memorial lectures at leading law institutions across the country, ensuring that his abiding commitment to justice, compassion, and service to the marginalized continues to guide successive generations of the legal profession.

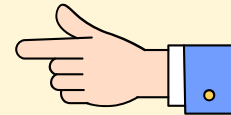
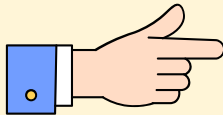


## Important Notes

1. Any alteration/change in the names of the team members shall be intimated in writing by the team requesting such alteration/change positively to the Organizing Committee. However, any such alteration is permitted only once.
2. Each team shall consist only of three members, comprising two speakers and one Researcher.
3. Once the competition commences, the team composition cannot be altered under any circumstances.
4. Inability of any team member to participate shall lead to disqualification of the team from the competition.
5. The composition of team members cannot be changed after registration except on approval of the organizing committee.
6. Once Registration is done no changes in names shall be allowed.
7. The Organizing Committee shall send a confirmation of participation email after verifying the entire process.
8. The participants may change their roles within their team only after prior intimation and approval of organizing committee.
9. Any failure or non-adherence with the aforementioned procedure may be treated as withdrawal from the competition and no claims of whatsoever nature shall be entertained thereafter.
10. The participants should not use any offensive or derogatory language during the entire event.
11. Failure to observe any of this rule shall lead to disqualification of the erring team.
12. The committee reserves all the right to field dummy teams from MLU to ensure an even number of participants; however, these teams will not be considered for ranking purposes.
13. There shall be no TA/DA, accommodation or other expenses incurred in connection with the event shall be provided to the participants.
14. Details of all the rounds shall be intimated to the concerned students through mail.

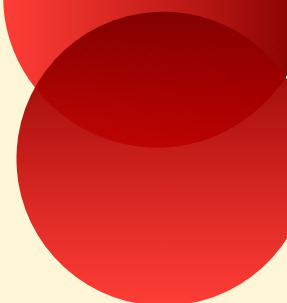
