Principal Hedayatul Munir was an outstanding legal scholar and a great teacher. He was an antithesis of an old school and his creative ways of teaching always had a profound impact on students' lives. He passed his H.S.L.C Examination from Don Bosco School Guwahati and Bachelor of Science (B.Sc.) from B. Borooah College, Guwahati. He also upholds his Master Degree in Law from Aligarh Muslim University, Uttar Pradesh. He started his professional career in law as a full-time Lecturer at the Barpeta Law College in 1978. Subsequently, he successfully cleared the Assam Public Service Commission (APSC) Examination and joined B. R. M Government Law College as a Lecturer. Alongside his academic career, he practised as an Advocate at the Gauhati High Court. Upon being appointed as the principal of B.R.M. Government Law College, he discontinued his legal practice to devote himself fully to academic administration and legal education. Notable, he was a member of the Gauhati University Executive Council contributing to the governance and development of higher education in the State of Assam. He was the Founding Trustee of NEF Trust, Guwahati, which established a host of Educational Institutions including NEF Law College.

RULES & REGULATIONS

1. Each institution will be allowed to be represented by maximum of three teams (each team consisting of two debaters), one speaking for the motion and the other against the motion.
2. Individual participation is also encouraged.
3. The mover will be allotted 5 minutes to speak, while all other participants will be allotted 4 minutes each. The mover will be given an additional 2 minutes to sum up the motion, which will not be considered for evaluation.
4. A warning bell will be given after 3 minutes.
5. Debaters may speak in Assamese, English or Hindi. Mixing or switching between languages during the speech is not permitted.
6. It is mandatory for all the teams/individual participants to complete their registration through the Google Form link provided below.
7. The registration window will remain open from 10th of September 2026 to 30th of September 2026.
8. The decision of the judges shall be final and binding.
9. Individual trophies will be awarded to each member of the winning team and to the individual winners.
10. Certificate of Participation will be provided to all participants.
11. The registration fee is non-refundable in the event of cancellation of participation.
12. No TA/DA will be provided to any participant.
